StudentWatch Suite is an online system built specifically for public schools that reports, communicates, documents and tracks safety issues including bullying, fighting and other behavioral problems. Integrated with this web-based program is a system for students and parents to anonymously report safety concerns about themselves or other students, either online or via telephone. The “anonymity” factor helps students feel more comfortable reporting bullying and other sensitive information, and the program goes even further by communicating directly to key administrators when time is of the essence. The systems within the suite provide reports and trends data on safety issues both for individual schools and district-wide to evaluate the effectiveness of current safety programs.

Components of the StudentWatch Suite include the Student Bullying/Safety Concern Reporting System mentioned above, the Student Accident Management System which tracks and documents student accident reports, and the Student Behavior Management System which allows for reporting and tracking of referral and non-referral behavior incidents as well as good behavior reporting and positive behavior awards. All systems can be integrated with the other systems to provide a comprehensive student health, safety and behavior management system.

Judges said they haven't found anything like this program, and agreed it would be very helpful for teachers, parents, and students to stay in communication—making the school environment as safe as possible.
